## **PURPOSE**

This policy provides a set of guidelines for the installation of school bus warning signs on roads under the care and control of Wudinna District Council.

## **APPLICATION**

All applications for signage installation are to be made in writing to Council.

### **ASSESSMENT OF APPLICATION**

Warning signs are used to warn traffic of potentially hazardous conditions on or adjacent to the road. They advise of conditions which require caution on the part of the driver and may call for a reduction of speed in the interest of the safety of the driver and of other road users. In general, warning signs will not be installed at bus stop locations. Signs will only be used as a last resort in hazardous locations and will not be used to justify unsafe stopping areas.

Upon application, a Council representative will undertake an assessment of the stopping area to determine sight distance and shoulder width. As a minimum, stopping sight distance (SSD) shall be available for vehicles approaching from the rear and front of the bus.

Guidelines for the sight distance from bus stop locations used for the assessment are as follows:

If the available sight distance is less than the SSD, preference will be given to finding a safer alternative location. Signage will only be installed where terrain and roadway features limit sight distance for approaching vehicles and the bus stop cannot be relocated to a more visible location.

Should the Council representative not deem it appropriate for the installation of a school bus sign, it will not be installed, subject to appeal to Council (See Complaints Policy and Procedure).

#### 4. INSTALLATION OF SIGNAGE

If required, the warning sign shall be a W6-SA3, Children Crossing sign with W8-SA56 supplementary plate which has the legend "School Bus". (Refer DIT - Manual of Legal Responsibilities and Technical Requirements for Traffic Control Devices (Part 2 – Code of Technical Requirements).

Council employees will install the signage once all fees and charges have been paid by the applicant (refer to Fees and Charges).

### 5. OWNERSHIP OF SIGNAGE

The sign and all other associated accessories will remain the property of Wudinna District Council.

## 6. REMOVAL OF SIGNAGE

Signs left in locations where buses no longer stop may lead to an increased general disregard of these signs by drivers. It is the responsibility of the applicant to inform Council when the school bus stop is no longer in use so that signage can be removed.

#### 7. FEES AND CHARGES

The cost incurred for erection and removal of these signs shall be met by the applicant.

Supply and installation charges for the School Bus Signs are set by Council as part of the annual budget process. Fees are available by contacting the Council Office or from our website <a href="www.wudinna.sa.gov.au">www.wudinna.sa.gov.au</a>.
