#### 11.4.1 Review of Council By-Laws

- In exercise of the powers contained in section 246 of the Local Government Act 1999, having satisfied the consultation requirements of the Act and having had regard to the outcome of the consultation process, the National Competition Policy Report, the Certificates of Validity provided by the Council's legal practitioner and the comments from the Dog and Cat Management Board in relation to By-Laws numbers 5 and 6, the majority of Council, in the presence of at least two thirds of its members, hereby makes and passes the following By-laws as attached to the Officer Manager report titled Review of Council By-Laws:

### 2. Blanket Unconditional Exemption raised by Council at it's 21 November 2023 meeting with respect to By Law 7 Local Government Land, clauses 10.11.4.2 and 10.11.4.4

#### 11.4.4 By Law 7 – Local Government Land

In exercise of its power under clause 14.3 of the Council's Local Government Land By-law 2023 No. 7 (the By-law") the Council hereby grants, for so long as the By-law is in force, an unconditional exemption such that a vulnerable person and a vulnerable person's carer is exempt from compliance with clause 10.11.4.2 and 10.11.4.4 of the By-Law.
